



I. A PROFILE OF SILAPATHAR COLLEGE

The Silapathar College established in 1979 is located in the heart of a rapidly growing small township - Silapathar which is surrounded by villages of tribal and backward communities in the Dhemaji District of Assam.

The institution is permanently affiliated to the Dibrugarh University. It was brought under deficit system of grant-in-aid in 1992 and was subsequently provincialised in 2005 by the Government of Assam. The college registered under 2(f) and 12(b) of UGC Act 1956 was first accredited by NAAC at the B level with institutional score of 72.00 on 28 February, 2005. It was then, subsequently re-accredited (cycle 2) with CGPA of 2.98 as B++ Grade on 21st August, 2023.

The college provides education for Higher Secondary and Under Graduate levels in Arts and Science streams. Diploma & PG programme under the Directorate of Open and Distance Learning (DODL), Dibrugarh University & UG programme under Krishna Kanta Handiqui State Open University (KKHSOU) - both in distance mode are offered in the college.

Silapathar College has been placed in the 99th,95th and 138th position among the Best Arts colleges of India by India Today- MDRA in 2018,2019 and 2020 respectively.

2 VISION

The uneven wheel that dominates the college emblem with black spot in it stands for unequal progress and dynamism of civilization. The conical cap in the shape of the fore of a pipal leave on the wheel signifies the height or peak of modern civilization that has made way beyond stars.

The pipal tree also symbolizes Indian heritage of meditation for achieving knowledge. 7. DIBRUGARH UNIVERSITY REGULATIONS FOR THE FOUR YEAR UNDERGRADUATE PROGRAMMES (FYUGP) IN CHOICE BASED CREDIT SYSTEM (CBCS), 2023

In pursuance to the decision of the I27th Meeting of the Academic Council (Emergent), Dibrugarh University held on I8.05.2023 vide Resolution No. 01 has approved the Dibrugarh University Regulations for the Four Year Under Graduate Programmes (FYUGP) in Choice Based Credit System (CBCS) 2023.

7.1 Short Title, Commencement and Applicability

These Regulations shall be called the Dibrugarh University Regulations for the Four Year Undergraduate Programmes (FYUGP) in Choice Based Credit System (CBCS), 2023. These Regulations shall be effective for the Courses of Study leading to a UG Certificate, UG Diploma, Three Year UG Degree, Four Year UG Degree (Honours) and Four Year UG Degree (Honours with Research). Hereinafter, it will be referred to as Dibrugarh University Regulations for the Four Year Undergraduate Programme in Choice Based Credit System, 2023. The Regulations shall come in to effect from the Academic Session, 2023-2024. The Regulations shall be applicable to the students enrolled in the aforementioned academic programmes conducted by the Departments/ Centers for Studies of Dibrugarh University/Colleges/Institutes affiliated to/permitted by Dibrugarh University from the academic session 2023-24.

7.2 Objectives

The objectives of the regulations are—

- 7.2.1 To conduct undergraduate programmes-- UG Certificate, UG Diploma, Three Year UG Degree, Four Year UG Degree (Honours) and Four Year UG Degree (Honours with Research) in various fields of Study/Discipline as per the guidelines of UGC's Curriculum and Credit Framework in the light of NEP, 2020.
- 7.2.2 To provide a multidisciplinary set-up to build vibrant communities of scholars and peers, breakdown harmful silos, enable students to become well rounded across disciplines including artistic, creative, and analytical subjects as well as sports, develop active research communities across disciplines, increase resource efficiency across higher education.
- 7.2.3 To nurture avenues for developing holistic individuals through an identified set of skills and values.
- 7.2.4 To provide a student centric, flexible, choice based credit framework with multiple entry and exit options so that students can be facilitated to pursue the trail of career chosen by themselves as per their interest.

7.3 Graduate Attributes

- 3.1 Learning outcomes specific to disciplinary/interdisciplinary areas of learning: Graduates should be able to demonstrate the acquisition of
 - i. Comprehensive knowledge and coherent understanding of the chosen disciplinary/

- interdisciplinary areas of study in a broad multidisciplinary context.
- Practical, professional and procedural knowledge required for carrying out professional ii. or highly skilled work/tasks related to the chosen field of learning.
- Skills in areas related to specialization in the chosen disciplinary/multidisciplinary areas iii. of learning in a broad multidisciplinary context.
- iv. Capacity to extrapolate from what has been learned, translate concepts into real life situations and apply acquired competencies in new/unfamiliar contexts.
- 7.3.2 Generic learning Outcomes: Graduates should be able to demonstrate the capabilities of Complex problem solving, Critical thinking, creativity, communication skills, analytical reasoning, research related skills, coordinating/collaborating with others, leadership readiness/qualities, learning how to learn skills, digital and technological skills, multicultural competence and inclusive spirit, value inculcation, autonomy, responsibility and accountability, environmental awareness and action, community engagement and service and empathy.

7.4 Definitions:

- 7.4. I Undergraduate Programmes: Undergraduate programmes will include the following
 - UG Certificate programme: UG Certificate Programme leads to a UG certificate after (i) completing I year (2 semesters) of study in the chosen fields of study. Students on exit shall be awarded UG certificate (in the Field of Study/Discipline) after securing the requisite 44 Credits on completion of Semester II if, in addition, they complete one work based/skill based vocational course/internship of 4 credits within one year from the completion of 2nd semester examination. These students are allowed to re-enter the degree programme within a period of three years and complete the degree within the stipulated maximum period of seven years.
 - (ii) UG Diploma Programme: UG Diploma Programme leads to a UG diploma after 2 years (4 semesters) of study in the chosen fields of study. Students on exit shall be awarded UG Diploma (in the Field of Study/Discipline) after securing the requisite 88 Credits on completion of Semester IV if, in addition, they complete one work based/ skill based vocational course/internship of 4 credits within one year from the completion of 4th semester examination. These students are allowed to re-enter the degree programme within a period of three years and complete the degree within the maximum period of seven years.
 - Three Year UG Degree Programme (BA, B.Sc, B. Com and Bachelors in other disciplines) with single/double major: Students who wish to undergo a 3-year (6 semester) UG programme shall be awarded UG degree in the Major discipline after successful completion of three years, securing a minimum of 132 credits. Provision of double Major shall be implemented in due course of time.
 - Four Year UG Programme with honours (BA, B. Sc, B. Com and Bachelors in other disciplines) with single/double major: Students who wish to undergo a 4-year (8



- semester) UG programme shall be awarded UG Honours degree in the Major discipline after successful completion of four years, securing a minimum of 176 credits. Provision of double Major shall be implemented in due course of time.
- (v) Four Year UG Programme with honours with Research (BA, B. Sc, B. Com and Bachelors in other disciplines) with single/double major: Students who wish to undergo a 4-year (8 semester) UG programme shall be awarded UG Honours and research degree in the Major discipline after successful completion of four years with a rigorous research project, securing a minimum of 176 credits. Provision of double Major shall be implemented in due course of time.
- 7.4.2 **College:** The term 'College' means the Colleges and Institutes affiliated to or permitted by Dibrugarh University for conducting different academic programmes.
- **7.4.3 Department:** The term 'Department' is used to mean a Department of Dibrugarh University/ a College/Institute affiliated to/ permitted by Dibrugarh University.
- **7.4.4 Centre for Studies:** The term 'Centre for Studies' is used to mean a Centre for Studies of Dibrugarh University/a College/Institute affiliated to/ permitted by Dibrugarh University
- **7.4.5 Programme:** The term 'programme' is used to mean the whole learning experience or combination of courses pursued for a Certificate, Diploma or a Degree.
- **7.4.6 Course:** A "Course" means one of the specified units which goes to comprise a programme of study.
- **7.4.7 Academic Year:** An 'Academic Year' means a period of twelve months consisting of two semesters.
- **7. 4.8 Semester:** The word "semester" is used to mean a half-yearly term or term of studies including examinations, vacations and semester breaks.
- **7.4.9 Semester Duration:** A semester normally extends over a period of 15 class weeks. Each week has 30 hours of instruction spread over the week.
- **7.4.10In—semester:** The word "in-semester" is used to refer to the continuous evaluation within the half-yearly term.
- **7.4.11 End-semester:** The word "end-semester" is used to refer to the terminal processes of examinations and evaluations at the end but within the half-yearly term.
- 7.4.12 Credit: A 'credit' is a unit by which the coursework is measured. It determines the number of hours of instruction required per week over the duration of a semester (minimum 15

weeks). A course may have only a lecture component or a lecture and tutorial component or a lecture and practicum component or a lecture, tutorial and practicum component, or only practicum component. Credit shall be defined as

- **7.4.13** Academic Bank of Credits (ABC): 'Academic Bank of Credits (ABC)' is an academic service mechanism as a digital/virtual/online entity established and managed by MOE/UGC to facilitate students to become its academic account holders and paving the way of seamless student mobility, between or within degree-granting Higher Education Institutions (HEIs) through a formal system of credit recognition, credit accumulation, credit transfers and credit redemption to promote distributed and flexible teaching learning.
- **7.4.14** Academic Flexibility: 'Academic Flexibility' is the provision for innovative and interchangeable curricular structures to enable creative combinations of Courses/ Programmes in disciplines of study leading to Certificate/Diploma/Degree of study offering multiple entry and multiple exit facilities removing the rigid curricular boundaries and creating new possibilities of life-long learning.
- **7.4.15 Credit accumulation:** 'Credit Accumulation' means the facility created by ABC in the Academic Bank Account opened by the students across the country in order to transfer and consolidate the 'credits' earned by them by undergoing 'courses' in any of the eligible HEIs.
- **7.4.16 Credit recognition:** 'Credit Recognition' means the credits earned through eligible/ partnering HEIs and transferred directly to the ABC by the concerned HEIs.
- **7.4.17 Credit redemption:** 'Credit redemption' means the process of commuting the accrued 'credits' in the Academic Bank Account of the students maintained in ABC for the purpose of fulfilling the 'credits requirements' for the award of Certificates/Diplomas/Degrees etc. by the degree awarding HEIs.
- **7.4.18 Credit transfer:** 'Credit transfer' means the mechanism by which the eligible HEIs registered with ABC are able to receive or provide prescribed 'credits' to individual registered ABC account in adherence to the UGC credit norms for the 'course/s' registered by the desirous students in any HEIs within India.
- **7.4.19 Course teacher:** A 'Course teacher' is a teacher or any person who is engaged by the University/ College/Institute for teaching a Course. He/ she shall perform the following functions:
 - (i) Teaching the Course approved by the statutory authorities.
 - (ii) Maintaining attendance and performance records of all the students registered for the Course(s) he/she teaches.
 - (iii) Conducting In-semester Assessment (Internal Assessment)
 - (iv) Involving himself/herself in preparation and moderation of question papers, evaluation,



scrutiny and finalization of results of the course(s) etc. whenever needed.

- v) Participating in various curricular and co-curricular activities as and when necessary.
- (vi) Preparing syllabus of different Courses whenever necessary.
- 7.4.20 College/Departmental/Centre for Studies Four Year Undergraduate Programme (FYUGP) Board: There shall be a College/Departmental/Centre for Studies Four Year Undergraduate Programme (FYUGP) Board to monitor and supervise the implementation of the Undergraduate academic programmes, which shall be constituted as below:
- (i) For Colleges/Institutes:

Chairperson: The Principal of the College

Vice - Chairperson: The Vice-Principal of the College

Members: Heads of the Departments and the Coordinator, IQAC

Member Secretary : A Senior Teacher of the College nominated by the Principal of the college

(ii) For University Departments/Centre for Studies

Chairperson: Head of the Department/Chairperson of the Centre for Studies

Member: All the Course Teachers and the coordinator, DQAC

- 7.4.21 Dibrugarh University Four Year Undergraduate Programme (FYUGP) Board: There shall be a Dibrugarh University Four Year Undergraduate Programme (FYUGP) Board to be constituted as below:
- (i) Chairperson: Vice Chancellor
- (ii) Members: The Registrar, Deans of the Faculties of Studies, Controller of Examinations, the Director, IQAC, D.U, five Principals of the colleges to be nominated by the Vice-Chancellor, One Joint/ Deputy Controller of Examinations to be nominated by the Vice-Chancellor and the Inspector of Colleges.
- (iii) Member Secretary: The Deputy Registrar (Academic)

7.4.22 Semester Duration:

- i) Odd Semesters: July-December (including end-semester examinations and semester breaks)
- ii) Even Semester: January-June (including end-semester examinations and semester breaks)
 Any change in the Academic Calendar/Schedule may be made by the University whenever necessary.

7.5 Extent of Application:

The Regulations shall be applicable to the students enrolled for the Courses of Study leading to the UG Certificate, UG Diploma, Three Year UG Degree, Four Year UG Degree (Honours) and Four Year UG Degree (Honours with Research)

7.6 Academic Schedule: The Academic Schedule of the UG Certificate, UG Diploma, Three Year UG Degree, Four Year UG Degree (Honours) and Four Year UG Degree (Honours with Research) Programmes shall be administered as per the Academic Calendar of the University published for every academic session.

7.7 Admission Notice and Criteria:

7.7.1 Newspaper Notice/Notification through University/College/Institutes websites inviting



- applications for admission into the different programmes shall be issued by the Registrar of the University/Principals of the colleges/institutes as per the Academic Calendar of the University. The minimum eligibility for admission into the UG programmes shall be as below:
- 7.7.2 Minimum eligibility criteria for admission in Four Year Undergraduate programmes: Senior Secondary School Leaving Certificate or Higher Secondary (Class 12) Certificate obtained after successful completion of Grade 12 or equivalent stage of education and/or Admission test conducted by College/University/National Level Testing Agency/State Level Testing Agency.
- 7.7.3 Minimum eligibility criteria for multiple entry points of the UG programmes
 - 1st year: Senior Secondary School Leaving Certificate or Higher Secondary (Class 12) a. Certificate obtained after successful completion of Grade 12 or equivalent stage of education and/or Admission test conducted by College/University/National Level Testing Agency/State Level Testing Agency.
 - 2 nd year: A certificate obtained after successful completion of I year (2 semesters) of b. the undergraduate programme. These students are to take admission in the 2nd year within a period of three years from obtaining the UG certificate from Dibrugarh University or any other University/institution recognized by Dibrugarh University.
 - 3rd year: A diploma obtained after successful completion of 2 years (4 semesters) of C. the undergraduate programme. These students are to take admission in the 3rd year UG programme within a period of three years from obtaining the UG diploma from Dibrugarh University or any other University/institution recognized by Dibrugarh University.
 - d. 4th Year (Honours): A Bachelor's degree after successful completion of three years (6 semesters) of the Undergraduate programme obtained from Dibrugarh University or any other University/institution recognized by Dibrugarh University. These students are to complete the degree within the stipulated maximum period of seven years.
 - 4th Year (Honours with Research): A three year Bachelor Degree with a minimum of e. 7.5 CGPA. The minimum entry requirement for 4th year (Honours/Research) UG programme within a period of three years from obtaining 3 year Bachelor Degree from Dibrugarh University or any other University/institution recognized by Dibrugarh University. These students are to complete the degree within the stipulated maximum period of seven years.
- 7.7.4 The admission or eligibility criteria shall be fixed by the Academic Council from time to time whenever necessary. The University/ colleges/ institutes may also adopt own policy for admission or selection of eligible candidates for admission complying with the eligibility criteria as prescribed.
- 7.7.5 Statutory reservation policy of the government shall be followed in case of selection of eligible candidates for admission.

7.8.2 A Course may also take the form of a Dissertation/ Project work/ Practical training/Fieldwork/ Internship, etc.



7.8.3 A student shall have to study the academic programme as per the scheme of the Programme. Even if a candidate earns the required number of credits before completion of the full duration of the programme, he/she shall not be entitled for the degree.

7.9 Course Enrolment

- 7.9.1 The minimum and maximum credits to be opted by a student for qualifying of a Undergraduate programme shall be as per the Course Structure given as Annexure I.
- 7.9.2 Change in Major: Students shall be allowed to change major within the broad discipline at the end of the second semester by giving him/her sufficient time to explore interdisciplinary courses during the first year. The HEIs may create 10% additional seats over and above the sanctioned strength to accommodate the request for a change of major.
- 7.9.3 Change in Minor: Students shall be allowed to change Minor courses of his/her areas of interest within the broad discipline at the end of the third semester. If a student pursuing a major obtains a minimum of 12 credits from another branch then the student will be awarded Bachelor degree in previous with a minor in later.

7.10 Attendance

- 7.10.1 The Course Teacher shall be responsible for maintaining a record of attendance of students who have enrolled for the course.
- 7.10.2 All Course Teachers of college/institutions shall intimate the Principal/ Director of a college/ Institute through the Head of the Department concerned at least thirty calendar days before the last instruction day in the semester, the particulars of all students who have less than 80% of attendance during the total number of class days. In case of University Departments/ Centre for Studies all course teachers shall intimate the Head of the Department/Chairperson of the Centre for Studies concerned at least thirty calendar days before the last instruction day in the semester, the particulars of all students who have less than 80% of attendance during the total number of class days.
- 7.10.3 A student who has less than 80% attendance in average shall not be permitted to sit for the End-semester examination. However, that it shall be open to the University to grant exemption to a student who has attended a minimum of 70% classes but failed to obtain the prescribed 80% attendance for valid reasons, on recommendation of the Head/Chairperson/ Principals of the Department/Centre/College on payment of a prescribed fee(s). The Head of the Departments/Chairperson of the Centre for Studies/Principals of the Colleges shall announce the names of all students who shall not be eligible to take the Endsemester examinations in the various Programmes and send a copy of the same to the Controller of Examinations. Such candidates shall have to repeat the concerned Course(s) when it is offered next.
- 7.10.4 A student declared as dis-collegiate shall not be allowed to proceed to the next higher Semester. He/she shall need to pursue the Semester afresh in which he/she was declared as dis-collegiate along with the next fresh batch.



7.11 Examination and Evaluation:

- (a) Examination and evaluation shall be done on a continuous basis, at least two times during a Semester including the End Semester Examination.
- (b) There shall be 20% marks for in-semester assessment and 80% marks for End-semester examination in each course during every semester.
- (c) There shall be no provision for re-evaluation of the answer-scripts of the end-semester examinations. However, a candidate may apply for re-scrutiny.
- (d) In-semester Assessment:
 - (i) In in-semester assessment, different tools such as objective tests, written tests, assignments, paper presentation, laboratory work, etc. suitable to the courses may be employed.
 - (ii) The students shall be informed in advance about the nature of assessment. Students shall be required to compulsorily attend in-semester assessment including appearing the sessional tests, failing which they will not be allowed to appear for the End-semester examination. A Student cannot repeat In-semester examinations. The Department/ Centre for Studies may arrange special in-semester examination whenever necessary.
- (e) End Semester Examination:
 - (i) There shall be one End semester examination carrying 80% Marks in each course of a Semester covering the entire syllabus prescribed for the Course. The End semester examination is normally a written/laboratory-based examination/Project Work/Dissertation.
 - (ii) The Controller of Examinations shall make necessary arrangements for notifying the dates of the End semester examinations and other procedures as per Dibrugarh University Rules (at least 20 days in advance) and the Academic Calendar notified by the University.
 - (iii) The time given for End-semester examination for each Course shall be based on the credits/marks of the course.
 - (iv) Emphasis needs to be given on problem solving, application level questions as prescribed by National Education Policy, 2020. The question paper should include different forms of question.
- (f) Confidential Works: Setting of question papers, moderation of question papers, evaluation of answer scripts, scrutiny, tabulation of marks, etc. and announcement of results, shall be governed by the Dibrugarh University Examination Ordinance.
- (g) The mode of the conduct of the end-semester examinations of the practical/dissertation courses shall be partially external as below:
 - i. The end-semester examinations of all practical/dissertation courses shall be conducted by a Board of Examiners consisting of the internal examiner (the concerned course teacher) and an external examiner appointed by the Controller of Examinations.
 - ii. A student shall not be allowed to take more than one full course as project work in a



single semester.

- (h) The mode of end-semester examination and evaluation of the Course shall be specified in the detailed syllabus of the course concerned.
- (i) End-semester practical examinations shall normally be held before the theory examinations.
- (j) Betterment Examination:
 - i. A student shall be entitled to take the 'Betterment Examinations' in any two theory courses after successful completion of 3 year/4year programme only once. In this case, the higher marks secured by the student shall be retained. The candidates shall have to apply for betterment examination within one year of passing the Sixth/Eight Semester examination. Students shall have to appear in the betterment examination with the regular batch.
 - ii. No betterments shall be allowed in the practical/project/dissertation/internship examinations.

7.12 Results and Progression:

- 7.12.1 A candidate shall be declared as passed a Programme, provided he/she secures-
 - 7.12.1.1 At least 30% of marks in each Course in the End Semester Examinations combining both theory and practical examinations
 - 7.12.1.2 At least 'P' grade in the 10 point scale combining both the in-semester and End Semester Examination performance.
 - 7.12.1.3 There shall be no separate pass mark for In-semester Assessment.
- 7.12.2 A candidate shall be declared as passed a semester/ programme, provided he/ she secures at least 'P' grade in the 10 point scale (given in clause) in all the Courses separately.
- 7.12.3 There may be moderation of In-semester Assessment marks/End Semester marks as and when necessary.
- 7.12.4 The marks of In-semester examinations obtained by the candidate shall be carried over for declaring any result.
- 7.12.5 A candidate who fails or does not appear in one or more Courses of any end semester examinations up to fifth Semester shall be provisionally promoted to the next higher semester with the failed course as carry over course(s). Such candidates will be eligible to appear in the carryover course in the next regular examinations of those courses. If a candidate fails in any of the components (either theory or practical) of a course the candidate shall have to reappear in the examination for both the components.
- 7.12.6 If a candidate clears the sixth semester examination before clearing all the courses of the previous semesters, the result of the sixth semester examination of that candidate shall be withheld and his/ her results shall be announced only after he/ she clears the courses of the previous semesters.
- 7.12.7 A candidate who fails or does not appear in one or more courses of seventh semester



examinations shall be provisionally promoted to the eighth semester with the failed course as carry over course(s). If a candidate clears the eight semester examination before clearing all the courses of the seventh semesters, the result of the eighth semester examination of that candidate shall be withheld and his/ her results shall be announced only after he/ she clears the courses of the previous semester.

- 7.12.8 A student must clear all his/her Semester Examinations within six (6) years for three year undergraduate programme and seven years for four year undergraduate programme (with honours/research) from the dates of admission to the First Semester of any Programme irrespective of the number of examinations appeared by the student.
- 7.12.9 Since the Semester system involves continuous assessment, there shall be no scope for a student to appear as a private candidate in any programme in this system.
- 7.12.10A candidate shall be declared to have passed provided he/she has passed all the Semesters and in all the Courses separately for the concerned programme.
- 7.12.11 The Controller of Examinations shall declare the results of different programmes and issue Grade-sheets. The merit list shall be prepared only for the regular candidates and it does not include the backlog candidates.
- 7.12.12The first rank holder of a programme shall be decided on the basis of the CGPA. However, the Overall Weighted Percentage of Marks (OWPM) of a candidate shall be considered in case of tie in CGPA.
- 7.12.13 Results of the candidates appeared in the Betterment or Backlog Examinations shall not be counted for the award of Prizes/Medals, Rank or Distinction.

7.13. Provision of Multiple Exit:

- 7.13.1 Exit 1: There is a provision of exit after successful completion of I year (two semesters). A Certificate will be awarded when a student exits at the end of year I (2 semesters). Students who have secured minimum of 44 credits will be awarded a UG certificate (in the field of study/discipline) if, in addition, they complete one work based/skill based vocational course/internship of 4 credits within one year from the completion of 2nd semester examination.
- 7.13.2 Exit 2:There is a provision of exit after successful completion of 2 years (four semesters. A Diploma will be awarded when a student exits at the end of year 2 (4 semesters). Students who have secured minimum of 88 credits will be awarded a UG Diploma (in the field of study/discipline) if, in addition, they complete one work based/skill based vocational course/internship of 4 credits within one year from the completion of 4th Semester examination.
- 7.13.3 Exit 3:Three Year UG Degree Programme (BA, B. Sc, B. Com and Bachelor in other discipline) with single/double major:There is a provision of exit after successful completion of 3 years (six semesters). Students who wish to undergo a 3-year UG programme shall be awarded UG degree in the major discipline after successful completion of three years, securing 132 credits.
- 13.4 Four Year UG Programme with Honours (BA, B.Sc, B. Com and Bachelor in other discipline)



with single/double major: Students who wish to undergo a 4-year (8 semester) UG programme shall be awarded UG Honours degree in the major discipline after successful completion of four years with Discipline Specific Elective Courses in 7th and 8th semesters in lieu of Research Project and Dissertation, securing a minimum of 176 credits.

- (iii) Conversion of CGPA in to percentage (%): CGPA will be multiplied by 10. Percentage of marks = $(CGPA \times I0)$
- (iv) The Letter grade 'B+' and above shall be considered as First Class and Letter grade 'B' shall be considered as Second Class.
- A student is considered to have completed a course successfully and earned the prescribed credits if he/she secures a letter grade other than F (Failed) or 'Abs' (Absent/ Incomplete).
- (vi) If a candidate secures 'F' grade in a Course, he/she shall have to reappear in the Course in the next legitimate chance.
- (vii) If a student secures 'F' grade in Project Work/ Dissertation/ assignment etc., he/she shall have to re-submit it after necessary revisions. The Result shall be declared with next regular batch.
- (viii) 'Abs' grade shall be awarded to a candidate if he/she has not fulfilled the following requirements:
 - If a candidate fails to appear in any Course(s) in an end semester examination. (a)
 - If a candidate fails to submit the project work/dissertation / assignment of an end semester examination.
 - If a candidate is certified as not eligible to appear in any course(s) in an end semester examination by the Course Teacher(s) due to insufficient attendance in lectures, tutorials practical or fieldworks.
- (ix) The candidates not appearing in a Semester Examination shall be considered as an 'Abs' candidate and that will be reflected in the Grade Sheet of the candidate. These candidates shall have to convert the 'Abs' grade by appearing in the next examination on the Course (provided he/ she has legitimate chance to appear the Course) concerned or by submitting project work/dissertation/ assignment etc.

7.16 Transcript

The University may issue consolidated Transcript on payment of a prescribed fee which shall contain Letter grades, grade points and SGPA and CGPA mentioning the Course Titles in details, medium of instruction and programme duration.

7.17 Academic Bank of Credit:

- 7.17.1 Institution Registration:
- 7.17.1.1.1 The HEIs shall register on NAD/ABC in the concerned portal. Institution shall designate a Nodal Officer and set up a dedicated NAD/ABC cell for implementation of NAD/ ABC Scheme and reflect their details (Name, Designation, Mobile No. and email id) on its website.
- 7.17.1.1.2 I Institution shall advise the students to register on ABC through the ABC portal
- 7.17.1.1.3 I Institution shall make ABC id a mandatory field in the admission forms, Examination



forms or if possible on students Identity card also.

- 7.17.1.1.4 I Institution shall display the posters and templates and place them on the canteen, Library, Notice Board and around the playground or the place where there is maximum movements of students
- 7.17.1.1.5 I Institution shall organize Seminar/Workshop for information and publicity about ABC in campus as well as respective affiliated colleges.
- 7.17.2 Student Registration: Students shall register themselves by visiting the ABC website and creating a student account through the concerned institution and records has to be submitted to the institution.
- 7.18 Credit Transfer: Inter- Institutional transfer of Credits may be considered by the Dibrugarh University on reciprocal basis or in compliance with the relevant Guidelines of the UGC. However, a candidate from other university has to fulfill minimum credit requirements as prescribed by Dibrugarh University.

7.19 Mentor Mentee Forum

There shall be Mentor Mentee forums in each semester in each of the Department and Centre for Studies. The forum will be comprised of the Mentor to be appointed by the Head of the department/Chairperson of the Centre for Studies and assigned mentees. Concerned mentor shall act as Chairperson and a nominated/selected mentee as Coordinator.

- 7.19.1 Functions of Mentor Mentee forum will be—
 - 7.19.1.1 Dealing with the issues experienced by the mentees in the classroom, laboratories, internship, field work, project work etc or in any other academic activities.
 - 7.19.1.2 Orienting the mentees the details of the FYUGP regulation.
 - 7.19.1.3 Orienting the mentees with the academic schedule including the dates of assessment and the syllabus coverage for each assessment.
 - 7.19.1.4 Analyzing the performance of the mentees after each of the tests and finding the ways to improve.
 - 7.19.1.5 Conducting at least one meeting in a month
- 7.19.2 Functions of Mentor Mentee forum will be-
 - 7.19.2.1.1.1 To act as a link between the Head of the Department/Chairperson of the Centre for Studies and the concerned mentees.
 - 7.19.2.1.1.2 To collect and maintain various records as required by the Department/ Chairperson of the Centre for Studies.
 - 7.19.2.1.1.3 Guiding the mentees in various academic functions
 - 7.19.2.1.1.4 To monitor the academic performances of the mentees.
 - 7.19.2.1.1.5 To organize mentor mentee meeting.

7.20 General:

 It shall be ensured that the University shall maintain fundamental code of professional ethics in implementing these Regulations.

8. **ATTENDANCE**

HS COURSE a)

Students attending 75% or more classes shall be allowed to appear in the examination as Regular Candidates. Students attending 60% or more classes but less than 75% shall be allowed to appear at the examination as Non-Collegiate Candidates on payment of a Non-Collegiate Fee fixed by the AHSEC. A student attending less than 60% of classes shall be declared as **Dis-collegiate** and will be debarred from appearing in the Annual/Final Examination. Penalty will be charged (prescribed by office from time to time) on the students who have failed to appear in the internal periodical examinations. The holding of examination and declaration of the result of the Annual Examination will be regulated by the norms of the Assam Higher Secondary Education Council.

12. RED RIBBON CLUB:

It envisages instilling charity mind among all the students to extend their able help towards developing healthy life styles, donating blood to all the needy by promotion of regular voluntary blood donation.

13. ECO CLUB:

National Green Corps (NGC) is a major initiative of Ministry of Environment, Forest and Climate Change (MoEFCC) for creating environmental awareness launched in 2001-02. It aims at building cadres of young children working towards environmental conservation and sustainable development. The phenomenal response that NGC received has made the network with more than 1, 00,000 Eco Clubs across the country in 16 years. This is one of the largest conservation networks at grass root level in taking the environment awareness among the masses. Silapathar College has also set up Eco Club from the session 2018-19 with Dr Abdul Mutalib, Assistant Professor of Sociology as the Coordinator.

14. ENVIRONMENT CLIMATE CELL:

Silapathar College has constituted an Environment Climate Cell in order to make the students as well as teachers aware about the environmental issues and challenges and impart them to disseminate the information and sensitize the school children and society. The main objective of



this cell are to provide opportunities to acquire knowledge, skills, attitude, commitment to preserve the environment, to make them understand the interdepence of economic, social and ecological factors etc. Dr. Upen Deka, Asstt. prof. Deptt. of Botany is the co-ordinator of this cell.

15. YOGA AND MEDITATION CENTRE:

Considering the importance of practicing yoga to improve flexibility, balance, endurance and physical strength while meditation helps to keep the mind sharp and clean relieves stress and improves overall well being, the college has Yoga and Meditation centre to promote health benefits among the faculty and students through Yoga and Meditation. The centre celebrates International Day of Yoga every year since its inception. Techniques of meditation and various postures are performed to lead a healthy and stress free life. Dr. Sukanya Baruah, Asst. Prof. Dept. of Chemistry is the coordiantor of this centre.

The College has constituted an Entreprenuership Cell which addresses all the needs of students to become dynamic entreprenuer. The main objectives of this cell is to create awareness on Entreprenuership among the students through training programmes and camps, to enhance industry, institute interaction through guest lectures and industrial visits. 17. **SEMINARS & WORKSHOPS**

To provide a platform for exchanging scholarly views and sharing expertise among the teachers, state and national seminars and workshops are organized by the college from time to time. Through such academic exercises, teachers are expected to widen their knowledge and experience and get inspired in research. Students are also given opportunity to enhance their learning experiences through such programmes.

18. GUARDIAN FEEDBACK MECHANISM

The college has also an in-built Guardian Feedback Mechanism wherein the responsibilities of the Guardians and the institution are thoroughly discussed in the meetings held.

19. INTER-COLLEGE FACULTY EXCHANGE PROGRAMME

Silapathar College has also introduced Inter-college Faculty Exchange Programme inviting faculty members to deliver lectures on mutual basis from adjoining colleges.

20. INTER-COLLEGE STUDENT EXCHANGE PROGRAMME

The college organises inter-college student exchange programme from time to time where students from other institutions are invited for interaction and exchange of ideas. Similarly, students from our institution shall also attend such programmes as and when invited.

21. ADMISSION PROCEDURE



Admission procedure in the college has been upgraded to Online System from the session 2017-18 session and now it is being done through SAMARTH & DARPAN for UG and HS Courses respectively.

However, hard copy of documents as required should be submitted to the office at the time of admission.

The reservation policy will be followed as per Govt. rules at the time of Admission.

As per the direction of the Govt. there is provision for free admission (except Students' Union Fee) on submission of following documents:

- i) BPL certificate and
- ii) Evidence (photograph) of plantation of tree.

Note:

- Students having less than 40% marks in aggregate need not apply for admission. However, relaxation of 5% is provided for SC/ST students.
- Students must have H.S. (10+2) pass and obtained atleast 45% marks in aggregate and 50% marks in concern (Honours) subject.
- The college authority shall have the right to reject admission to any one without assigning any reason thereof.

22. DECLARATION

A DECLARATION form will have to signed by the student as well as the Guardian at the time of admission for maintenance of strict maintain discipline either individually or in a body in the college campus. Any student found to have detrimental conduct to academic environment of the college shall attract severe punishment which may lead to expulsion from the college. (Declaration forms are attached as **Annexure IV, V, VI & VII**).

23. RESERVATION OF SEATS

Reservation of seats is provided as per Govt. rules for:

- a) 2% for Sports Persons of sports recognized by IOA/SAI and aslo have represented District/ State etc.
- b) 1% for wards of employees of the Colleges
- c) 1% for NCC/Scouts/Guides.
- d) 1% for the Students with achievements in cultural activities.

24. UNIFORM

Wearing of uniform in the college campus by students is mandatory. Any student found without uniform is not allowed to attend classes or transact any matter in the college office. The uniform of the college is described below:

25. **GENERAL RULES**

- i) Every student of the college must strictly maintain discipline either individually or in a body in the college campus. Any student found to have a conduct detrimental to academic environment of the college shall immediately be expelled from the college.
- Every student of the college is a member of the Silapathar College Students' Union and, ii) therefore, he/she will have to participate in any event organized by the union. The Union will have to function within the framework of its constitution.
- All notices/posters/banners desired to be circulated on the notice board or elsewhere iii) within the college campus shall require prior permission of the Principal.
- The signature of the Principal on the Identity Card must be obtained within 15 days from the date of admission. The Identity Card must be kept in possession by all students in the college campus all the time.
- All the office bearers of the Students' Union must submit their audited accounts and allied v) documents/materials to the Principal at the end of academic session immediately before filling up the forms for examination.
- vi) All students including the office bearers of the Union must obtain Library Clearance Certificate from the authority concerned before filling up forms for examination.
- vii) Damage or destruction of college properties and involvement in causing disruption of normal functioning of classes is treated as punishable offence which may lead to imposition of fine along with expulsion from the college.
- Indecent behaviour by students towards teachers and employees of the college will be viii) seriously dealt with.
- Use of drugs, cigar and other narcotic substances is strictly prohibited. ix)
- x) Tearing of library books, journals, etc will lead to punishment along with due compensation.
- xi) Wearing of uniform in indecent way, bearing of informal haircut etc. are strictly prohibited.

STUDENTS' ORGANISATION a)

- ii) A Cash Prize of Rs. 5000.00 (Five thousand) and a Certificate of Merit to the H.S. student of this college securing highest marks in History in the State and to Under Graduate student securing highest marks in History Honours in Dibrugarh University in the Final examination will be awarded by Dr. L.N. Pegu, Principal of this college in memory of Late Deben Pegu.

e) STUDENTS' AID FUND

- **Book Bank:** Under the scheme of Book Bank facility, loan of text books are given to poor and meritorious students.

27. LIBRARY

28. LANGUAGE LAB

The college has a fully air-conditioned 31 plus computers Language Lab with video conferencing facility. The students are given free access.

29. SCIENCE LABORATORY: The college has well established Science Laboratory with latest equipments.

30. WOMEN'S HOSTEL

The college has a Girls' Hostel with adequate amenities. Students seeking seats in the hostel must fill in a separate Hostel Admission Form obtainable from the college office which have to be submitted within stipulated time. All boarders must abide by the following rules and regulations:

- The boarders must maintain decent, dignified and disciplined principle of life in and outside (i) the hostel.
- No visitor is allowed to meet any boarder without the permission of the hostel (ii) superintendent.
- (iii) Use of mobile phone is normally not allowed.
- (iv) All boarders must follow the mess rules in force in the hostel.
- Violation of hostel rules will be seriously treated as punishable offence which may lead to (v) expulsion from the hostel as well as the college.

The worm casts contain five times more nitrogen, seven times more phosphorus and II times more potasium than ordinary soil, nutrients essential for healthy plant growth.

The college has introduces the internal assessment and evaluation system (IAES) to satisfy the norms of continuous and comprehensive evaluation of students is primarily based on the following parameters

Students are advised to fulfil different preconditions satisfactorily to secure a higher grade in IAES. Moreover, under the Semester System in Under Graduate level under Dibrugarh University, the following norms and procedures will be followed for internal Assessment and evaluation.

- ١. 20% of the total marks of each paper will be allotted as the marks for Internal Assessment.
- 2. The marks distribution of Internal Assesment from the allotted 20% marks is as follows
 - 25% from overall attendance of student
 - 25% from 1st Sessional Examination (SEI)
 - 25% from 2nd Sessional Examination (SEII)
 - 25% from Seminar, group Discussion etc.

Annexure - III

Rules for Internal Assessment in B.A & B.Sc. (NEP 2020) Programmes in Semester System

- Ι. The marks allotted for Internal Assessment (20%) in each course shall be based on the following:
 - One Sessional Examination (Written): 10% of the marks allotted for internal assessment.
 - b) Any one of the following activities listed below 10 marks
 - i) Seminar/ Group Discussion/ Assignment related to the course content.
 - ii) Presentation of Seminar Papers
 - iii) Assignment
 - iv) Quiz
- 2. Each sessional examination shall be conducted by the concerned teacher(s) of the course. The setting of question paper, invigilation duty, evaluation of answer scripts for each paper shall be done by the concerned teacher(s) as a part of his/her/their normal duty. The teacher concerned shall fix the date of the sessional examination of each course complying with the Academic Calendar of the University.
- 3. The students shall have to write the answers in the scripts provided and duly authenticated by the college/ institute concerned.
- 4. After evaluation, the answer scripts should be shown to the students and corrections should be made if necessary. After this, the answer scripts should be collected back from the students.
- 5. There shall be no provision for "repeat"/ "betterment" in the sessional examination. If a student misses any sessional examination for unavoidable reasons, the concerned teacher may allow the student to appear in a separate examination at his/her own discretion.
- 6. The marks of internal assessment secured by a candidate shall be carried over to next legitimate chances.
- 7. If a course is taught by more than one teacher then the concerned teachers shall conduct the process of internal assessment together.
- 6. If any student fails to appear in internal assessment, he/she shall not be eligible to appear in the end semester examinations of the course(s) concerned. The colleges/ institutes shall notify the same prior to filling up forms for examinations.
- 7. At the end of the semester (before the end-semester examinations begin) the concerned College shall submit the internal assessment marks in proper format to the University.
- 8. The University may call the answer scripts from the colleges/institute at any time during the academic sessions.
