## 1. A PROFILE OF SILAPATHAR COLLEGE

The Silapathar College established in 1979 is located in the heart of a rapidly growing small township - Silapathar which is surrounded by villages of tribal and backward communities in the Dhemaji District of Assam.

The institution is permanently affiliated to the Dibrugarh University. It was brought under deficit system of grant-in-aid in 1992 and was subsequently provincialised in 2005 by the Government of Assam. The college registered under 2(f) and 12(b) of UGC Act 1956 was first accredited by NAAC at the B level with institutional score of 72.00 on 28 February, 2005. It was then, subsequently re-accredited (cycle 2) with CGPA of 2.98 as B++ Grade on 21st August, 2023.

The college provides education for Higher Secondary and Under Graduate levels in Arts and Science streams. Diploma & PG programme under the Directorate of Open and Distance Learning (DODL), Dibrugarh University & UG programme under Krishna Kanta Handiqui State Open University (KKHSOU) - both in distance mode are offered in the college.

*Silapathar College has been placed in the 99th, 95th and 138th position among the Best Arts colleges of India by India Today- MDRA in 2018, 2019 and 2020 respectively.*

## 2. VISION

Spreading the walls of quality higher education by dissolving barriers and creating an apt environment for holistic progression of the students, academically and beyond with focus on the rich multi-cultural milieu of the land.

## 4. THE COLLEGE EMBLEM

The uneven wheel that dominates the college emblem with black spot in it stands for unequal progress and dynamism of civilization. The burning lamp (pradip) amidst darkness (black spot) within the wheel symbolizes light of knowledge – knowledge is power — to be achieved by endeavour. The conical cap in the shape of the fore of a pipal leaf on the wheel signifies the height or peak of modern civilization that has made way beyond stars.

The pipal tree also symbolizes Indian heritage of meditation for achieving knowledge. The band on which the sentence “অজ্ঞানত পথত জ্ঞানৰ প্ৰদীপ” is inscribed in Assamese meaning ‘we are the seekers of light (knowledge) in thorny paths’ is obliquely folded at the bottom as a base on which the name of the institution, “চিলাপথাৰ মহাবিদ্যালয়”





(Silapathar College) is inscribed.

## 7. **DIBRUGARH UNIVERSITY REGULATIONS FOR THE FOUR YEAR UNDERGRADUATE PROGRAMMES (FYUGP) IN CHOICE BASED CREDIT SYSTEM (CBCS), 2023**

In pursuance to the decision of the 127th Meeting of the Academic Council (Emergent), Dibrugarh University held on 18.05.2023 vide Resolution No. 01 has approved the Dibrugarh University Regulations for the Four Year Under Graduate Programmes (FYUGP) in Choice Based Credit System (CBCS) 2023.

### 7.1 **Short Title, Commencement and Applicability**

These Regulations shall be called the Dibrugarh University Regulations for the Four Year Undergraduate Programmes (FYUGP) in Choice Based Credit System (CBCS), 2023. These Regulations shall be effective for the Courses of Study leading to a UG Certificate, UG Diploma, Three Year UG Degree, Four Year UG Degree (Honours) and Four Year UG Degree (Honours with Research). Hereinafter, it will be referred to as Dibrugarh University Regulations for the Four Year Undergraduate Programme in Choice Based Credit System, 2023. The Regulations shall come in to effect from the Academic Session, 2023-2024. The Regulations shall be applicable to the students enrolled in the aforementioned academic programmes conducted by the Departments/ Centers for Studies of Dibrugarh University/Colleges/Institutes affiliated to/permitted by Dibrugarh University from the academic session 2023-24.

### 7.2 **Objectives**

The objectives of the regulations are—

7.2.1 To conduct undergraduate programmes-- UG Certificate, UG Diploma, Three Year UG Degree, Four Year UG Degree (Honours) and Four Year UG Degree (Honours with Research) in various fields of Study/Discipline as per the guidelines of UGC's Curriculum and Credit Framework in the light of NEP, 2020.

7.2.2 To provide a multidisciplinary set-up to build vibrant communities of scholars and peers, breakdown harmful silos, enable students to become well rounded across disciplines including artistic, creative, and analytical subjects as well as sports, develop active research communities across disciplines, increase resource efficiency across higher education.

7.2.3 To nurture avenues for developing holistic individuals through an identified set of skills and values.

7.2.4 To provide a student centric, flexible, choice based credit framework with multiple entry and exit options so that students can be facilitated to pursue the trail of career chosen by themselves as per their interest.

### 7.3 **Graduate Attributes**

3.1 Learning outcomes specific to disciplinary/interdisciplinary areas of learning:

Graduates should be able to demonstrate the acquisition of

i. Comprehensive knowledge and coherent understanding of the chosen disciplinary/



- interdisciplinary areas of study in a broad multidisciplinary context.
- ii. Practical, professional and procedural knowledge required for carrying out professional or highly skilled work/tasks related to the chosen field of learning.
- iii. Skills in areas related to specialization in the chosen disciplinary/multidisciplinary areas of learning in a broad multidisciplinary context.
- iv. Capacity to extrapolate from what has been learned, translate concepts into real life situations and apply acquired competencies in new/unfamiliar contexts.

7.3.2 Generic learning Outcomes: Graduates should be able to demonstrate the capabilities of Complex problem solving, Critical thinking, creativity, communication skills, analytical reasoning, research related skills, coordinating/collaborating with others, leadership readiness/qualities, learning how to learn skills, digital and technological skills, multicultural competence and inclusive spirit, value inculcation, autonomy, responsibility and accountability, environmental awareness and action, community engagement and service and empathy.

#### 7.4 Definitions:

**7.4.1 Undergraduate Programmes :** Undergraduate programmes will include the following

- (i) UG Certificate programme: UG Certificate Programme leads to a UG certificate after completing 1 year (2 semesters) of study in the chosen fields of study. Students on exit shall be awarded UG certificate (in the Field of Study/Discipline) after securing the requisite 44 Credits on completion of Semester II if, in addition, they complete one work based/skill based vocational course/internship of 4 credits within one year from the completion of 2nd semester examination. These students are allowed to re-enter the degree programme within a period of three years and complete the degree within the stipulated maximum period of seven years.
- (ii) UG Diploma Programme: UG Diploma Programme leads to a UG diploma after 2 years (4 semesters) of study in the chosen fields of study. Students on exit shall be awarded UG Diploma (in the Field of Study/Discipline) after securing the requisite 88 Credits on completion of Semester IV if, in addition, they complete one work based/skill based vocational course/internship of 4 credits within one year from the completion of 4th semester examination. These students are allowed to re-enter the degree programme within a period of three years and complete the degree within the maximum period of seven years.
- (iii) Three Year UG Degree Programme (BA, B. Sc, B. Com and Bachelors in other disciplines) with single/double major: Students who wish to undergo a 3-year (6 semester) UG programme shall be awarded UG degree in the Major discipline after successful completion of three years, securing a minimum of 132 credits. Provision of double Major shall be implemented in due course of time.
- (iv) Four Year UG Programme with honours (BA, B. Sc, B. Com and Bachelors in other disciplines) with single/double major: Students who wish to undergo a 4-year (8



semester) UG programme shall be awarded UG Honours degree in the Major discipline after successful completion of four years, securing a minimum of 176 credits. Provision of double Major shall be implemented in due course of time.

- (v) Four Year UG Programme with honours with Research (BA, B.Sc, B. Com and Bachelors in other disciplines) with single/double major: Students who wish to undergo a 4-year (8 semester) UG programme shall be awarded UG Honours and research degree in the Major discipline after successful completion of four years with a rigorous research project, securing a minimum of 176 credits. Provision of double Major shall be implemented in due course of time.

**7.4.2 College:** The term 'College' means the Colleges and Institutes affiliated to or permitted by Dibrugarh University for conducting different academic programmes.

**7.4.3 Department:** The term 'Department' is used to mean a Department of Dibrugarh University/ a College/Institute affiliated to/ permitted by Dibrugarh University.

**7.4.4 Centre for Studies:** The term 'Centre for Studies' is used to mean a Centre for Studies of Dibrugarh University/a College/Institute affiliated to/ permitted by Dibrugarh University

**7.4.5 Programme:** The term 'programme' is used to mean the whole learning experience or combination of courses pursued for a Certificate, Diploma or a Degree.

**7.4.6 Course:** A "Course" means one of the specified units which goes to comprise a programme of study.

**7.4.7 Academic Year:** An 'Academic Year' means a period of twelve months consisting of two semesters.

**7.4.8 Semester:** The word "semester" is used to mean a half-yearly term or term of studies including examinations, vacations and semester breaks.

**7.4.9 Semester Duration:** A semester normally extends over a period of 15 class weeks. Each week has 30 hours of instruction spread over the week.

**7.4.10 In-semester:** The word "in-semester" is used to refer to the continuous evaluation within the half-yearly term.

**7.4.11 End-semester:** The word "end-semester" is used to refer to the terminal processes of examinations and evaluations at the end but within the half-yearly term.

**7.4.12 Credit:** A 'credit' is a unit by which the coursework is measured. It determines the number of hours of instruction required per week over the duration of a semester (minimum 15

**7.4.13 Academic Bank of Credits (ABC):** 'Academic Bank of Credits (ABC)' is an academic service mechanism as a digital/virtual/online entity established and managed by MOE/UGC to facilitate students to become its academic account holders and paving the way of seamless student mobility, between or within degree-granting Higher Education Institutions (HEIs) through a formal system of credit recognition, credit accumulation, credit transfers and credit redemption to promote distributed and flexible teaching learning.

**7.4.14 Academic Flexibility:** 'Academic Flexibility' is the provision for innovative and interchangeable curricular structures to enable creative combinations of Courses/ Programmes in disciplines of study leading to Certificate/Diploma/Degree of study offering multiple entry and multiple exit facilities removing the rigid curricular boundaries and creating new possibilities of life-long learning.

**7.4.15 Credit accumulation:** 'Credit Accumulation' means the facility created by ABC in the Academic Bank Account opened by the students across the country in order to transfer and consolidate the 'credits' earned by them by undergoing 'courses' in any of the eligible HEIs.

**7.4.16 Credit recognition:** 'Credit Recognition' means the credits earned through eligible/partnering HEIs and transferred directly to the ABC by the concerned HEIs.

**7.4.17 Credit redemption:** 'Credit redemption' means the process of commuting the accrued 'credits' in the Academic Bank Account of the students maintained in ABC for the purpose of fulfilling the 'credits requirements' for the award of Certificates/Diplomas/Degrees etc. by the degree awarding HEIs.

**7.4.18 Credit transfer:** 'Credit transfer' means the mechanism by which the eligible HEIs registered with ABC are able to receive or provide prescribed 'credits' to individual registered ABC account in adherence to the UGC credit norms for the 'course/s' registered by the desirous students in any HEIs within India.

**7.4.19 Course teacher:** A 'Course teacher' is a teacher or any person who is engaged by the University/ College/Institute for teaching a Course. He/ she shall perform the following functions:

- (i) Teaching the Course approved by the statutory authorities.
- (ii) Maintaining attendance and performance records of all the students registered for the Course(s) he/she teaches.
- (iii) Conducting In-semester Assessment (Internal Assessment)
- (iv) Involving himself/herself in preparation and moderation of question papers, evaluation,





scrutiny and finalization of results of the course(s) etc. whenever needed.

- (v) Participating in various curricular and co-curricular activities as and when necessary.
- (vi) Preparing syllabus of different Courses whenever necessary.

**7.4.20 College/Departmental/Centre for Studies Four Year Undergraduate Programme (FYUGP) Board:** There shall be a College/Departmental/Centre for Studies Four Year Undergraduate Programme (FYUGP) Board to monitor and supervise the implementation of the Undergraduate academic programmes, which shall be constituted as below:

- (i) For Colleges/Institutes:  
Chairperson : The Principal of the College  
Vice - Chairperson: The Vice-Principal of the College  
Members : Heads of the Departments and the Coordinator, IQAC  
Member Secretary : A Senior Teacher of the College nominated by the Principal of the college
- (ii) For University Departments/Centre for Studies  
Chairperson: Head of the Department/Chairperson of the Centre for Studies  
Member : All the Course Teachers and the coordinator, DQAC

**7.4.21 Dibrugarh University Four Year Undergraduate Programme (FYUGP) Board:** There shall be a Dibrugarh University Four Year Undergraduate Programme (FYUGP) Board to be constituted as below:

- (i) Chairperson : Vice Chancellor
- (ii) Members : The Registrar, Deans of the Faculties of Studies, Controller of Examinations, the Director, IQAC, D.U, five Principals of the colleges to be nominated by the Vice-Chancellor, One Joint/ Deputy Controller of Examinations to be nominated by the Vice-Chancellor and the Inspector of Colleges.
- (iii) Member Secretary : The Deputy Registrar (Academic)

**7.4.22 Semester Duration:**

- i) Odd Semesters: July–December (including end-semester examinations and semester breaks)
  - ii) Even Semester: January-June (including end-semester examinations and semester breaks)
- Any change in the Academic Calendar/Schedule may be made by the University whenever necessary.

**7.5 Extent of Application:**

The Regulations shall be applicable to the students enrolled for the Courses of Study leading to the UG Certificate, UG Diploma, Three Year UG Degree, Four Year UG Degree (Honours) and Four Year UG Degree (Honours with Research)

**7.6 Academic Schedule:** The Academic Schedule of the UG Certificate, UG Diploma, Three Year UG Degree, Four Year UG Degree (Honours) and Four Year UG Degree (Honours with Research) Programmes shall be administered as per the Academic Calendar of the University published for every academic session.

**7.7 Admission Notice and Criteria:**

7.7.1 Newspaper Notice/Notification through University/College/Institutes websites inviting



applications for admission into the different programmes shall be issued by the Registrar of the University/Principals of the colleges/institutes as per the Academic Calendar of the University. The minimum eligibility for admission into the UG programmes shall be as below:

**7.7.2 Minimum eligibility criteria for admission in Four Year Undergraduate programmes:**

Senior Secondary School Leaving Certificate or Higher Secondary (Class 12) Certificate obtained after successful completion of Grade 12 or equivalent stage of education and/or Admission test conducted by College/University/National Level Testing Agency/State Level Testing Agency.

**7.7.3 Minimum eligibility criteria for multiple entry points of the UG programmes**

- a. 1st year: Senior Secondary School Leaving Certificate or Higher Secondary (Class 12) Certificate obtained after successful completion of Grade 12 or equivalent stage of education and/or Admission test conducted by College/University/National Level Testing Agency/State Level Testing Agency.
- b. 2nd year: A certificate obtained after successful completion of 1 year (2 semesters) of the undergraduate programme. These students are to take admission in the 2nd year within a period of three years from obtaining the UG certificate from Dibrugarh University or any other University/institution recognized by Dibrugarh University.
- c. 3rd year: A diploma obtained after successful completion of 2 years (4 semesters) of the undergraduate programme. These students are to take admission in the 3rd year UG programme within a period of three years from obtaining the UG diploma from Dibrugarh University or any other University/institution recognized by Dibrugarh University.
- d. 4th Year (Honours): A Bachelor's degree after successful completion of three years (6 semesters) of the Undergraduate programme obtained from Dibrugarh University or any other University/institution recognized by Dibrugarh University. These students are to complete the degree within the stipulated maximum period of seven years.
- e. 4th Year (Honours with Research): A three year Bachelor Degree with a minimum of 7.5 CGPA. The minimum entry requirement for 4th year (Honours/Research) UG programme within a period of three years from obtaining 3 year Bachelor Degree from Dibrugarh University or any other University/institution recognized by Dibrugarh University. These students are to complete the degree within the stipulated maximum period of seven years.

7.7.4 The admission or eligibility criteria shall be fixed by the Academic Council from time to time whenever necessary. The University/ colleges/ institutes may also adopt own policy for admission or selection of eligible candidates for admission complying with the eligibility criteria as prescribed.

7.7.5 Statutory reservation policy of the government shall be followed in case of selection of eligible candidates for admission.

**7.8 Course Structure:**



7.8.1	The Course Structure of the Undergraduate Academic	Programmes shall be as per the Course
1	<b>Major Discipline:</b> Major discipline provides the opportunity for a student to pursue in-depth study of a particular subject or discipline	Major Discipline (Core) Major discipline is the discipline or subject of Main Focus and the degree will be awarded in that discipline. Students should secure the prescribed number of credits (about 50% of total credits) through core courses of the major discipline.

7.8.3 A student shall have to study the academic programme as per the scheme of the Programme. Even if a candidate earns the required number of credits before completion of the full duration of the programme, he/she shall not be entitled for the degree.

### **7.9 Course Enrolment**

7.9.1 The minimum and maximum credits to be opted by a student for qualifying of a Undergraduate programme shall be as per the Course Structure given as Annexure I.

7.9.2 Change in Major: Students shall be allowed to change major within the broad discipline at the end of the second semester by giving him/her sufficient time to explore interdisciplinary courses during the first year. The HEIs may create 10% additional seats over and above the sanctioned strength to accommodate the request for a change of major.

7.9.3 Change in Minor: Students shall be allowed to change Minor courses of his/her areas of interest within the broad discipline at the end of the third semester. If a student pursuing a major obtains a minimum of 12 credits from another branch then the student will be awarded Bachelor degree in previous with a minor in later.

### **7.10 Attendance**

7.10.1 The Course Teacher shall be responsible for maintaining a record of attendance of students who have enrolled for the course.

7.10.2 All Course Teachers of college/institutions shall intimate the Principal/ Director of a college/ Institute through the Head of the Department concerned at least thirty calendar days before the last instruction day in the semester, the particulars of all students who have less than 80% of attendance during the total number of class days. In case of University Departments/ Centre for Studies all course teachers shall intimate the Head of the Department/Chairperson of the Centre for Studies concerned at least thirty calendar days before the last instruction day in the semester, the particulars of all students who have less than 80% of attendance during the total number of class days.

7.10.3 A student who has less than 80% attendance in average shall not be permitted to sit for the End-semester examination. However, that it shall be open to the University to grant exemption to a student who has attended a minimum of 70% classes but failed to obtain the prescribed 80% attendance for valid reasons, on recommendation of the Head/Chairperson/ Principals of the Department/Centre/College on payment of a prescribed fee(s).

The Head of the Departments/Chairperson of the Centre for Studies/Principals of the Colleges shall announce the names of all students who shall not be eligible to take the End-semester examinations in the various Programmes and send a copy of the same to the Controller of Examinations. Such candidates shall have to repeat the concerned Course(s) when it is offered next.

7.10.4 A student declared as dis-collegiate shall not be allowed to proceed to the next higher Semester. He/she shall need to pursue the Semester afresh in which he/she was declared as dis-collegiate along with the next fresh batch.





### 7.11 Examination and Evaluation:

- (a) Examination and evaluation shall be done on a continuous basis, at least two times during a Semester including the End Semester Examination.
- (b) There shall be 20% marks for in-semester assessment and 80% marks for End-semester examination in each course during every semester.
- (c) There shall be no provision for re-evaluation of the answer-scripts of the end-semester examinations. However, a candidate may apply for re-scrutiny.
- (d) In-semester Assessment:
  - (i) In in-semester assessment, different tools such as objective tests, written tests, assignments, paper presentation, laboratory work, etc. suitable to the courses may be employed.
  - (ii) The students shall be informed in advance about the nature of assessment. Students shall be required to compulsorily attend in-semester assessment including appearing the sessional tests, failing which they will not be allowed to appear for the End-semester examination. A Student cannot repeat In-semester examinations. The Department/ Centre for Studies may arrange special in-semester examination whenever necessary.
- (e) End Semester Examination:
  - (i) There shall be one End semester examination carrying 80% Marks in each course of a Semester covering the entire syllabus prescribed for the Course. The End semester examination is normally a written/laboratory-based examination/Project Work/ Dissertation.
  - (ii) The Controller of Examinations shall make necessary arrangements for notifying the dates of the End semester examinations and other procedures as per Dibrugarh University Rules (at least 20 days in advance) and the Academic Calendar notified by the University.
  - (iii) The time given for End-semester examination for each Course shall be based on the credits/marks of the course.
  - (iv) Emphasis needs to be given on problem solving, application level questions as prescribed by National Education Policy, 2020. The question paper should include different forms of question.
- (f) Confidential Works: Setting of question papers, moderation of question papers, evaluation of answer scripts, scrutiny, tabulation of marks, etc. and announcement of results, shall be governed by the Dibrugarh University Examination Ordinance.
- (g) The mode of the conduct of the end-semester examinations of the practical/dissertation courses shall be partially external as below:
  - i. The end-semester examinations of all practical/dissertation courses shall be conducted by a Board of Examiners consisting of the internal examiner (the concerned course teacher) and an external examiner appointed by the Controller of Examinations.
  - ii. A student shall not be allowed to take more than one full course as project work in a



single semester.

- (h) The mode of end-semester examination and evaluation of the Course shall be specified in the detailed syllabus of the course concerned.
- (i) End-semester practical examinations shall normally be held before the theory examinations.
- (j) **Betterment Examination:**
  - i. A student shall be entitled to take the 'Betterment Examinations' in any two theory courses after successful completion of 3 year/4year programme only once. In this case, the higher marks secured by the student shall be retained. The candidates shall have to apply for betterment examination within one year of passing the Sixth/Eight Semester examination. Students shall have to appear in the betterment examination with the regular batch.
  - ii. No betterments shall be allowed in the practical/project/dissertation/internship examinations.

### **7.12 Results and Progression:**

- 7.12.1 A candidate shall be declared as passed a Programme, provided he/she secures-
  - 7.12.1.1 At least 30% of marks in each Course in the End Semester Examinations combining both theory and practical examinations
  - 7.12.1.2 At least 'P' grade in the 10 point scale combining both the in-semester and End Semester Examination performance.
  - 7.12.1.3 There shall be no separate pass mark for In-semester Assessment.
- 7.12.2 A candidate shall be declared as passed a semester/ programme, provided he/ she secures at least 'P' grade in the 10 point scale (given in clause) in all the Courses separately.
- 7.12.3 There may be moderation of In-semester Assessment marks/End Semester marks as and when necessary.
- 7.12.4 The marks of In-semester examinations obtained by the candidate shall be carried over for declaring any result.
- 7.12.5 A candidate who fails or does not appear in one or more Courses of any end semester examinations up to fifth Semester shall be provisionally promoted to the next higher semester with the failed course as carry over course(s). Such candidates will be eligible to appear in the carryover course in the next regular examinations of those courses. If a candidate fails in any of the components (either theory or practical) of a course the candidate shall have to reappear in the examination for both the components.
- 7.12.6 If a candidate clears the sixth semester examination before clearing all the courses of the previous semesters, the result of the sixth semester examination of that candidate shall be withheld and his/ her results shall be announced only after he/ she clears the courses of the previous semesters.
- 7.12.7 A candidate who fails or does not appear in one or more courses of seventh semester



examinations shall be provisionally promoted to the eighth semester with the failed course as carry over course(s). If a candidate clears the eighth semester examination before clearing all the courses of the seventh semesters, the result of the eighth semester examination of that candidate shall be withheld and his/ her results shall be announced only after he/ she clears the courses of the previous semester.

- 7.12.8 A student must clear all his/her Semester Examinations within six (6) years for three year undergraduate programme and seven years for four year undergraduate programme (with honours/research) from the dates of admission to the First Semester of any Programme irrespective of the number of examinations appeared by the student.
- 7.12.9 Since the Semester system involves continuous assessment, there shall be no scope for a student to appear as a private candidate in any programme in this system.
- 7.12.10 A candidate shall be declared to have passed provided he/she has passed all the Semesters and in all the Courses separately for the concerned programme.
- 7.12.11 The Controller of Examinations shall declare the results of different programmes and issue Grade-sheets. The merit list shall be prepared only for the regular candidates and it does not include the backlog candidates.
- 7.12.12 The first rank holder of a programme shall be decided on the basis of the CGPA. However, the Overall Weighted Percentage of Marks (OWPM) of a candidate shall be considered in case of tie in CGPA.
- 7.12.13 Results of the candidates appeared in the Betterment or Backlog Examinations shall not be counted for the award of Prizes/Medals, Rank or Distinction.

### 7.13. Provision of Multiple Exit:

- 7.13.1 Exit 1: There is a provision of exit after successful completion of 1 year (two semesters). A Certificate will be awarded when a student exits at the end of year 1 (2 semesters). Students who have secured minimum of 44 credits will be awarded a UG certificate (in the field of study/discipline) if, in addition, they complete one work based/skill based vocational course/ internship of 4 credits within one year from the completion of 2nd semester examination.
- 7.13.2 Exit 2: There is a provision of exit after successful completion of 2 years (four semesters). A Diploma will be awarded when a student exits at the end of year 2 (4 semesters). Students who have secured minimum of 88 credits will be awarded a UG Diploma (in the field of study/discipline) if, in addition, they complete one work based/skill based vocational course/ internship of 4 credits within one year from the completion of 4th Semester examination.
- 7.13.3 Exit 3: Three Year UG Degree Programme (BA, B. Sc, B. Com and Bachelor in other discipline) with single/double major: There is a provision of exit after successful completion of 3 years (six semesters). Students who wish to undergo a 3-year UG programme shall be awarded UG degree in the major discipline after successful completion of three years, securing 132 credits.
- 13.4 Four Year UG Programme with Honours (BA, B. Sc, B. Com and Bachelor in other discipline)



with single/double major: Students who wish to undergo a 4-year (8 semester) UG programme shall be awarded UG Honours degree in the major discipline after successful completion of four years with Discipline Specific Elective Courses in 7th and 8th semesters in lieu of Research Project and Dissertation, securing a minimum of 176 credits.

- 13.5 Four Year UG Programme with Honours with Research (BA, B. Sc, B. Com and Bachelor in other discipline) with single/double major: Students who wish to undergo a 4-year (8 semester) UG programme shall be awarded UG Honours with Research degree in the major discipline after successful completion of four years, with Research Project and Dissertation in 7th and 8th Semesters, securing 176 credits.

7.15.3 Computation of SGPA and CGPA: The procedure to compute the SGPA and CGPA are given below

- (i) The SGPA is the ratio of the sum of the products of the number of credits with the grade points scored by a student in all the courses taken by a student and the sum of the number of credits off all the courses undergone by a student.

$$SGPA(S_i) = \frac{\sum C_i G_i}{\sum C_i}$$

Where  $C_i$  is the number of credit of the  $i$ th course and  $G_i$  is the grade point scored by the student in the  $i$ th course.

The SGPA and CGPA shall be rounded off to two decimal points and reported in the transcripts.

- (iii) **Conversion of CGPA in to percentage (%):** CGPA will be multiplied by 10.  
Percentage of marks = (CGPA X 10)
- (iv) The Letter grade 'B+' and above shall be considered as First Class and Letter grade 'B' shall be considered as Second Class.
- (v) A student is considered to have completed a course successfully and earned the prescribed credits if he/she secures a letter grade other than F (Failed) or 'Abs' (Absent/Incomplete).
- (vi) If a candidate secures 'F' grade in a Course, he/she shall have to reappear in the Course in the next legitimate chance.
- (vii) If a student secures 'F' grade in Project Work/ Dissertation/ assignment etc., he/she shall have to re-submit it after necessary revisions. The Result shall be declared with next regular batch.
- (viii) 'Abs' grade shall be awarded to a candidate if he/she has not fulfilled the following requirements:
  - (a) If a candidate fails to appear in any Course(s) in an end semester examination.
  - (b) If a candidate fails to submit the project work/dissertation / assignment of an end semester examination.
  - (c) If a candidate is certified as not eligible to appear in any course(s) in an end semester examination by the Course Teacher(s) due to insufficient attendance in lectures, tutorials practical or fieldworks.
- (ix) The candidates not appearing in a Semester Examination shall be considered as an 'Abs' candidate and that will be reflected in the Grade Sheet of the candidate. These candidates shall have to convert the 'Abs' grade by appearing in the next examination on the Course (provided he/ she has legitimate chance to appear the Course) concerned or by submitting project work/dissertation/ assignment etc.

### 7.16 Transcript

The University may issue consolidated Transcript on payment of a prescribed fee which shall contain Letter grades, grade points and SGPA and CGPA mentioning the Course Titles in details, medium of instruction and programme duration.

### 7.17 Academic Bank of Credit:

7.17.1 Institution Registration:

7.17.1.1.1 The HEIs shall register on NAD/ABC in the concerned portal. Institution shall designate a Nodal Officer and set up a dedicated NAD/ABC cell for implementation of NAD/ABC Scheme and reflect their details (Name, Designation, Mobile No. and email id) on its website.

7.17.1.1.2 | Institution shall advise the students to register on ABC through the ABC portal

7.17.1.1.3 | Institution shall make ABC id a mandatory field in the admission forms, Examination



forms or if possible on students Identity card also.

7.17.1.1.4 | Institution shall display the posters and templates and place them on the canteen, Library, Notice Board and around the playground or the place where there is maximum movements of students

7.17.1.1.5 | Institution shall organize Seminar/Workshop for information and publicity about ABC in campus as well as respective affiliated colleges.

7.17.2 Student Registration: Students shall register themselves by visiting the ABC website and creating a student account through the concerned institution and records has to be submitted to the institution.

**7.18 Credit Transfer:** Inter- Institutional transfer of Credits may be considered by the Dibrugarh University on reciprocal basis or in compliance with the relevant Guidelines of the UGC. However, a candidate from other university has to fulfill minimum credit requirements as prescribed by Dibrugarh University.

### **7.19 Mentor Mentee Forum**

There shall be Mentor Mentee forums in each semester in each of the Department and Centre for Studies. The forum will be comprised of the Mentor to be appointed by the Head of the department/Chairperson of the Centre for Studies and assigned mentees. Concerned mentor shall act as Chairperson and a nominated/selected mentee as Coordinator.

7.19.1 Functions of Mentor Mentee forum will be—

7.19.1.1 Dealing with the issues experienced by the mentees in the classroom, laboratories, internship, field work, project work etc or in any other academic activities.

7.19.1.2 Orienting the mentees the details of the FYUGP regulation.

7.19.1.3 Orienting the mentees with the academic schedule including the dates of assessment and the syllabus coverage for each assessment.

7.19.1.4 Analyzing the performance of the mentees after each of the tests and finding the ways to improve.

7.19.1.5 Conducting at least one meeting in a month

7.19.2 Functions of Mentor Mentee forum will be—

7.19.2.1.1.1 To act as a link between the Head of the Department/Chairperson of the Centre for Studies and the concerned mentees.

7.19.2.1.1.2 To collect and maintain various records as required by the Department/Chairperson of the Centre for Studies.

7.19.2.1.1.3 Guiding the mentees in various academic functions

7.19.2.1.1.4 To monitor the academic performances of the mentees.

7.19.2.1.1.5 To organize mentor mentee meeting.

### **7.20 General:**

a. It shall be ensured that the University shall maintain fundamental code of professional ethics in implementing these Regulations.

## 8. ATTENDANCE

### a) HS COURSE

Students attending **75%** or more classes shall be allowed to appear in the examination as **Regular Candidates**. Students attending 60% or more classes but less than 75% shall be allowed to appear at the examination as **Non-Collegiate Candidates** on payment of a Non-Collegiate Fee fixed by the AHSEC. A student attending less than 60% of classes shall be declared as **Dis-collegiate** and will be debarred from appearing in the Annual/Final Examination. **Penalty will be charged (prescribed by office from time to time) on the students who have failed to appear in the internal periodical examinations.** The holding of examination and declaration of the result of the Annual Examination will be regulated by the norms of the Assam Higher Secondary Education Council.

#### **12. RED RIBBON CLUB:**

Red Ribbon Club is a movement started by the Government of India in Schools and Colleges through which, students will spread awareness over HIV/AIDS. It envisages instilling charity mind among all the students to extend their able help towards developing healthy life styles, donating blood to all the needy by promotion of regular voluntary blood donation.

With an aim to create awareness on HIV/AIDS, the Assam State Aids Control Society (ASACS) has formed a number of Red Ribbon Clubs (RRCs) in the schools and colleges of the state through the National Service Scheme (NSS) as the nodal agency for RRC. #### **13. ECO CLUB:**

National Green Corps (NGC) is a major initiative of Ministry of Environment, Forest and Climate Change (MoEFCC) for creating environmental awareness launched in 2001-02. It aims at building cadres of young children working towards environmental conservation and sustainable development. The phenomenal response that NGC received has made the network with more than 1,00,000 Eco Clubs across the country in 16 years. This is one of the largest conservation networks at grass root level in taking the environment awareness among the masses. Silapathar College has also set up Eco Club from the session 2018-19 with Dr. Abdul Mutalib, Assistant Professor of Sociology as the Coordinator.

#### **14. ENVIRONMENT CLIMATE CELL :**

Silapathar College has constituted an Environment Climate Cell in order to make the students as well as teachers aware about the environmental issues and challenges and impart them to disseminate the information and sensitize the school children and society. The main objective of



this cell are to provide opportunities to acquire knowledge, skills, attitude, commitment to preserve the environment, to make them understand the interdependence of economic, social and ecological factors etc. Dr. Upen Deka, Asstt. prof. Deptt. of Botany is the co-ordinator of this cell.

#### **15. YOGA AND MEDITATION CENTRE:**

Considering the importance of practicing yoga to improve flexibility, balance, endurance and physical strength while meditation helps to keep the mind sharp and clean relieves stress and improves overall well being, the college has Yoga and Meditation centre to promote health benefits among the faculty and students through Yoga and Meditation. The centre celebrates International Day of Yoga every year since its inception. Techniques of meditation and various postures are performed to lead a healthy and stress free life. Dr. Sukanya Baruah, Asst. Prof. Dept. of Chemistry is the coordiantor of this centre.

The College has constituted an Entrepreneurship Cell which addresses all the needs of students to become dynamic entrepreneur. Through such academic exercises, teachers are expected to widen their knowledge and experience and get inspired in research. Students are also given opportunity to enhance their learning experiences through such programmes.

#### **21. ADMISSION PROCEDURE**





Admission procedure in the college has been upgraded to Online System from the session 2017-18 session and now it is being done through SAMARTH & DARPAN for UG and HS Courses respectively.

However, hard copy of documents as required should be submitted to the office at the time of admission.

The reservation policy will be followed as per Govt. rules at the time of Admission.

As per the direction of the Govt. there is provision for free admission (except Students' Union Fee) on submission of following documents:

- i) BPL certificate and
- ii) Evidence (photograph) of plantation of tree.

**Note :**

- *Students having less than 40% marks in aggregate need not apply for admission. However, relaxation of 5% is provided for SC/ST students.*
- *Students must have H.S. (10+2) pass and obtained atleast 45% marks in aggregate and 50% marks in concern (Honours) subject.*
- *The college authority shall have the right to reject admission to any one without assigning any reason thereof.*

## 22. DECLARATION

A DECLARATION form will have to signed by the student as well as the Guardian at the time of admission for maintenance of strict maintain discipline either individually or in a body in the college campus. Any student found to have detrimental conduct to academic environment of the college shall attract severe punishment which may lead to expulsion from the college. (*Declaration forms are attached as **Annexure IV, V, VI & VII***).

## 23. RESERVATION OF SEATS

Reservation of seats is provided as per Govt. rules for:

- a) 2% for Sports Persons of sports recognized by IOA/SAI and aslo have represented District/ State etc.
- b) 1% for wards of employees of the Colleges
- c) 1% for NCC/Scouts/Guides.
- d) 1% for the Students with achievements in cultural activities.

## 24. UNIFORM

Wearing of uniform in the college campus by students is mandatory. Any student found without uniform is not allowed to attend classes or transact any matter in the college office. The uniform of the college is described below:



- i) For Boys: Black trouser (long pant) and light blue shirt.
- ii) For Girls: Light blue churidar kurta with white dupatta.
- iii) For both Boys and Girls : Black sweater.

## **25. GENERAL RULES**

- i) Every student of the college must strictly maintain discipline either individually or in a body in the college campus. Any student found to have a conduct detrimental to academic environment of the college shall immediately be expelled from the college.
- ii) Every student of the college is a member of the Silapathar College Students' Union and, therefore, he/she will have to participate in any event organized by the union. The Union will have to function within the framework of its constitution.
- iii) All notices/posters/banners desired to be circulated on the notice board or elsewhere within the college campus shall require prior permission of the Principal.
- iv) The signature of the Principal on the Identity Card must be obtained within 15 days from the date of admission. The Identity Card must be kept in possession by all students in the college campus all the time.
- v) All the office bearers of the Students' Union must submit their audited accounts and allied documents/materials to the Principal at the end of academic session immediately before filling up the forms for examination.
- vi) All students including the office bearers of the Union must obtain Library Clearance Certificate from the authority concerned before filling up forms for examination.
- vii) Damage or destruction of college properties and involvement in causing disruption of normal functioning of classes is treated as punishable offence which may lead to imposition of fine along with expulsion from the college.
- viii) Indecent behaviour by students towards teachers and employees of the college will be seriously dealt with.
- ix) Use of drugs, cigar and other narcotic substances is strictly prohibited.
- x) Tearing of library books, journals, etc will lead to punishment along with due compensation.
- xi) Wearing of uniform in indecent way, bearing of informal haircut etc. are strictly prohibited.
- xii) Use of mobile phone is normally not allowed in the college campus.

## **26. STUDENTS' SUPPORT SYSTEM**

### **a) STUDENTS' ORGANISATION**



Silapathar College Students' Union (SCSU) is the only bonafide students' organization in the college. No other students' body is allowed in the college campus. The objective of having this union body is to train the students' tolerance and democratic values by getting them involved in it. The office bearers of the union are elected annually by the students.

**b) STUDENTS' ADALAT**

Silapathar College aims to ensure that every student has equal access to competent and qualitative teaching which leads to vibrant academic, social and personal growth. To this end, the college has adopted a student charter wherein the students and the teachers meet on the 1st Saturday of every month to encourage the students in continuous and comprehensive learning and progression.

**c) FREE STUDENTSHIP**

There is also a provision of free studentship for the students who belong to any of the following categories:

- a) Poor and meritorious students
- b) Physically challenged

Students desirous of availing the facility have to apply to the Principal with documentary evidence. However, if the Government declares Fee Waiver Scheme to the student then this scheme will be opened to the student within the state but those student who belongs to poor and meritorious out side the state can avail the free studentship on submission of application with documentary evidence to the principal.

**d) SCHOLARSHIP**

- (ii) National Merit Scholarship
- (iii) State Merit Scholarship

In addition to the above scholarships, the following awards, prizes and certificates are awarded to the brilliant students of this college:

- i) A Cash Prize of Rs. 10,000.00 (Ten thousand) and a Certificate of Merit to the student of this college who secures a position among the first ten successful candidates of Assam in H.S. Examination.
- ii) A Cash Prize of Rs. 5000.00 (Five thousand) and a Certificate of Merit to the H.S. student of this college securing highest marks in History in the State and to Under Graduate student securing highest marks in History Honours in Dibrugarh University in the Final examination will be awarded by Dr. L.N. Pegu, Principal of this college in memory of **Late Deben Pegu**.

**e) STUDENTS' AID FUND**



- (i) **Project work** : On the basis of the recommendation of Research Committee Rs. 10,000/- will be provided to the aspiring student for project work.
- (ii) **Book Bank** : Under the scheme of Book Bank facility, loan of text books are given to poor and meritorious students.

## 27. LIBRARY

The college has a well-equipped automated library with a stock of 15757 total printed books, (12744 texts, 3013 reference) 10 journals, 10 magazines and 7 newspapers, 164300+ ebooks and 6000+ e-journals under N-List. Moreover, it provides e-access to many e-bboks under NDL and EPG pathshala.

29. **SCIENCE LABORATORY:** The college has well established Science Laboratory with latest equipments.

## 30. WOMEN'S HOSTEL

The college has a Girls' Hostel with adequate amenities. Students seeking seats in the hostel must fill in a separate Hostel Admission Form obtainable from the college office which have to be submitted within stipulated time. All boarders must abide by the following rules and regulations:

- (i) The boarders must maintain decent, dignified and disciplined principle of life in and outside the hostel.
- (ii) No visitor is allowed to meet any boarder without the permission of the hostel superintendent.
- (iii) Use of mobile phone is normally not allowed.
- (iv) All boarders must follow the mess rules in force in the hostel.
- (v) Violation of hostel rules will be seriously treated as punishable offence which may lead to expulsion from the hostel as well as the college.
- (vi) Damage of hostel property caused by any boarder will attract punishment along with charging of compensation. Depending upon the nature and reason of damage, she may be expelled from the hostel as well as the college.
- (vii) For maintenance of proper sanitary hygiene within the hostel, Napkine Incinerator is installed. The boarders shall have to use the same when needed.

**32. FACILITIES**

**a) DIGITAL CLASSROOM**

The digital turn in education has been described across a wide range of initiatives and processes. These include the introduction of digital tools and gadgets as a part of the learning environment, building digital archives and repositories of learning. Keeping in consonance with the present digital world, Silapathar College has installed digital classrooms to partially replace traditional classroom teaching for benefit of the students.

**b) VIRTUAL CLASS ROOM**

Silapathar College has a hi-tech state of the art Virtual class room. It will help develop new tools to enrich course-work, enhance flexibility, and attract the best students and faculty. Virtual class room lets institutions of higher education reach students anywhere, anytime, by blending fully interactive and recordable audio, video, and web conferencing capabilities. With these proven, powerful tools, educational institutions can extend the walls of their classrooms in both space and time, and bring the rest of the world to their campuses.

**c) MULTIPURPOSE GYMNASIUM:**

Multipurpose Gymnasium is constructed under Sports Infrastructure Grants UGC of XII plan period with state of the art facilities.

**d) HEALTH CARE CENTRE:**

The college has a Health Care Centre with essential infrastructure and first aid medicines to promote physical, mental & social well being of the students. A part time physician and a



nurse have been appointed for health check up. The college intends to provide health care information and become an important source of services for faculty, staff and students of the college. Besides for maintaining proper sanitary hygiene of the girl students, Sanitary Napkin Pad Incenerator installed at Girls' Common Room and Women's Hostel.

**e) MINI MUSEUM**

To show case the rich traditional and cultural heritage of the tribal and indigenous people of the North East, Silapathar College had established a mini museum under the UGC sponsored Tribal Study Centre in 2007.

**f) VERMI COMPOST**

The college has also started to recycle bio-waste by forming Vermi Compost Units in the college. Vermi composting is the process of using earthworms to turn organic wastes into very high-quality compost. The worm casts contain five times more nitrogen, seven times more phosphorus and 11 times more potassium than ordinary soil, nutrients essential for healthy plant growth.

**Overview** : The Dibrugarh University has introduced CBCS system in UG courses with effect from the academic session 2019-20. There are six semesters in UG courses over a period of three calendar years. The schedule for the semester system is as follows: First, third and fifth Semester (including examination): August to December; Second, fourth and sixth Semester (including examination): January to June. In CBCS, broadly there are two programmes: 1. B.Sc (Honours ) 2. B.Sc (Regular). The details of BSc (Honours and Regular) programme for Semester are as follows:

In **Semester -I B.Sc (Honours)**: One subject (Core course), English communication and one Generic Elective (GE) subject (Core course and GE must be two different subjects)

In **Semester -II B.Sc (Honours)**: One subject (Core course), one Generic Elective (GE) subject (Core course and GE must be two different subjects). Environmental Science (Ability Enhancement Course) is compulsory for students of all programmes.

In **Semester -III B.Sc (Honours)**: One subject (Core course), one skill enhancement course and one Generic Elective (GE) subject (Core course and GE must be two different subjects).

In **Semester -IV B.Sc (Honours)**: One subject (Core course), one skill enhancement course and one Generic Elective (GE) subject (Core course and GE must be two different subjects).

In **Semester -V B.Sc (Honours)**: One subject (Core course) and one discipline specific elective.

In **Semester -VI B.Sc (Honours)**: One subject (Core course) and one discipline specific elective.

A student's performance in the CBCS semester system shall be monitored throughout the semester by continuous assessment in both theory and practical papers. Evaluation in each theory and practical paper will be as follows:

**Internal evaluation:** 20% marks (includes sessional examinations/home assignments/ seminars/ group discussion)

**External evaluation:** 80% marks

Internal evaluation shall be based on sessional examinations, home assignments, class attendance, seminars, group discussion etc. in each semester while external evaluation shall be through a final examination at the end of the semester conducted by Dibrugarh University. Students must secure pass marks in both internal and external examinations separately. Programme Subjects to be taken Students must have minimum 75% class attendance for appearing the examination.

#### **Internal assessment and evaluation system (IAES)**

The college has introduced the internal assessment and evaluation system (IAES) to satisfy the norms of continuous and comprehensive evaluation of students is primarily based on the following parameters

1. Class attendance/ regularity of students in different subjects
2. Attendance in test/terminal examinations, unit test and marks secured/progress in these tests
3. Use of library services by the students.
4. Participation in seminars/discussions etc.
5. Participation in co-curricular activities
6. Teachers comments/views on a student
7. Performance in Home Assignments etc.

Students are advised to fulfil different preconditions satisfactorily to secure a higher grade in IAES. Moreover, under the Semester System in Under Graduate level under Dibrugarh University, the following norms and procedures will be followed for internal Assessment and evaluation.

1. 20% of the total marks of each paper will be allotted as the marks for Internal Assessment.
2. The marks distribution of Internal Assessment from the allotted 20% marks is as follows
  - \* 25% from overall attendance of student
  - \* 25% from 1<sup>st</sup> Sessional Examination (SEI)
  - \* 25% from 2<sup>nd</sup> Sessional Examination (SEII)

The Dibrugarh University has introduced CBCS system in UG courses with effect from the academic session 2019-20. There are six semesters in UG courses over a period of three calendar years. The schedule for the semester system is as follows: First, third and fifth Semester (including examination): August to December; Second, fourth and sixth Semester (including examination): January to June. In CBCS, broadly there are two programmes: 1. B.Sc. (Honours) 2. B.Sc. (Regular). The details of BSc (Honours and Regular) programme for Semester are as follows:

In **Semester -I B.Sc (Honours)**: One subject (Core course), English communication and one Generic Elective (GE) subject (Core course and GE must be two different subjects)

In **Semester -II B.Sc (Honours)**: One subject (Core course), one Generic Elective (GE) subject (Core course and GE must be two different subjects). Environmental Science (Ability Enhancement Course) is compulsory for students of all programmes.

In **Semester -III B.Sc (Honours)**: One subject (Core course), one skill enhancement course and one Generic Elective (GE) subject (Core course and GE must be two different subjects).

In **Semester -IV B.Sc (Honours)**: One subject (Core course), one skill enhancement course and one Generic Elective (GE) subject (Core course and GE must be two different subjects).

In **Semester -V B.Sc (Honours)**: One subject (Core course) and one discipline specific elective.

In **Semester -VI B.Sc (Honours)**: One subject (Core course) and one discipline specific elective.

A student's performance in the CBCS semester system shall be monitored throughout the semester by continuous assessment in both theory and practical papers. Evaluation in each theory and practical paper will be as follows:

**Internal evaluation:**

20% marks (includes sessional examinations/home assignments/ seminars/ group discussion)

**External evaluation: 80% marks**

Internal evaluation shall be based on sessional examinations, home assignments, class attendance, seminars, group discussion etc. in each semester while external evaluation shall be through a final examination at the end of the semester conducted by Dibrugarh University. Students must secure pass marks in both internal and external examinations separately. Programme Subjects to be taken Students must have minimum 75% class attendance for appearing the examination.

**Internal assessment and evaluation system (IAES)**

The college has introduced the internal assessment and evaluation system (IAES) to satisfy the norms of continuous and comprehensive evaluation of students is primarily based on the following parameters

1. Class attendance/ regularity of students in different subjects
2. Attendance in test/terminal examinations, unit test and marks secured/progress in these tests
3. Use of library services by the students.
4. Participation in seminars/discussions etc.
5. Participation in co-curricular activities
6. Teachers comments/views on a student
7. Performance in Home Assignments etc.

Students are advised to fulfil different preconditions satisfactorily to secure a higher grade in IAES. Moreover, under the Semester System in Under Graduate level under Dibrugarh University, the following norms and procedures will be followed for internal Assessment and evaluation.

1. 20% of the total marks of each paper will be allotted as the marks for Internal Assessment.
2. The marks distribution of Internal Assessment from the allotted 20% marks is as follows
  - 25% from overall attendance of student
  - 25% from 1<sup>st</sup> Sessional Examination (SEI)

**Rules for Internal Assessment in B.A & B.Sc. (NEP 2020) Programmes in Semester System**

1. The marks allotted for Internal Assessment (20% ) in each course shall be based on the following:
  - a) One Sessional Examination (Written): 10% of the marks allotted for internal assessment.
  - b) Any one of the following activities listed below 10 marks
    - i) Seminar/ Group Discussion/ Assignment related to the course content.
    - ii) Presentation of Seminar Papers
    - iii) Assignment
    - iv) Quiz
2. Each sessional examination shall be conducted by the concerned teacher(s) of the course. The setting of question paper, invigilation duty, evaluation of answer scripts for each paper shall be done by the concerned teacher(s) as a part of his/her/their normal duty. The teacher concerned shall fix the date of the sessional examination of each course complying with the Academic Calendar of the University.
3. The students shall have to write the answers in the scripts provided and duly authenticated by the college/ institute concerned.
4. After evaluation, the answer scripts should be shown to the students and corrections should be made if necessary. After this, the answer scripts should be collected back from the students.
5. There shall be no provision for "repeat"/ "betterment" in the sessional examination. If a student misses any sessional examination for unavoidable reasons, the concerned teacher may allow the student to appear in a separate examination at his/her own discretion.
6. The marks of internal assessment secured by a candidate shall be carried over to next legitimate chances.
7. If a course is taught by more than one teacher then the concerned teachers shall conduct the process of internal assessment together.
6. If any student fails to appear in internal assessment, he/she shall not be eligible to appear in the end semester examinations of the course(s) concerned. The colleges/ institutes shall notify the same prior to filling up forms for examinations.
7. At the end of the semester (before the end-semester examinations begin) the concerned College shall submit the internal assessment marks in proper format to the University.
8. The University may call the answer scripts from the colleges/institute at any time during the academic sessions.
